Sub.: Request for Extension of Provisional Affiliation Beyond 31/03/ 2018 – reg.

Sir/Madam,

This has reference to the Inspection report received (Inspection held on 14.09.2018) bearing registration EX-02734-1819 on the above subject.

In this regard, the following deficiencies / requirements have been observed during the scrutiny of the Inspection Report. The School is required to submit the specific compliance of the following deficiencies / requirements within 30 days.

1. The school is required to submit Recognition Certificate as per the Section 18 of Right to Education Act, 2009. If the school same has not been obtained earlier, school is directed to apply for recognition certificate immediately and submit the same to CBSE office within a period of one year on issuance of this grant letter.
2. On scrutiny of the Inspection Committee report it has been observed that the built up area of the school is not specified in the IC report. The school is required to specify the same.
3. As per Inspection Committee report area of playground is 12000 sq. feet whereas as per online application the area of playground is 12500 Sq. Mtrs. The school is required to clarified regarding above difference.
4. The school is required to construct pucca/concrete boundary wall around the playgrounds also and submit videography including top/aerial view of campus.
5. The school has submitted certificate issued by Gram panchayat, which is not sufficed. The School is required to submit Fire Safety Certificate issued by concerned Govt. authority (i.e. Fire Safety Department of the State).
6. The School is required to submit Building Safety Certificate issued by concerned Government Authority (i.e. Govt. Engineer).
7. The school is required to re-constitute **SMC** as per new Affiliation Bye-Laws, by including 02 representative of Parent of students which are studying in school, 02 teachers from same school and 02 teachers from any other school or college (of whom one shall be woman), School Principal as Member Secretary, at least 50% member in SMC should be woman. The school is required to forward a panel of 5-6 names of principals (at least 2 from KV/JNV) of Sr Secondary schools affiliated with the Board recommended so that 02 of them may be approved by the Board as its nominees in the School Managing Committee.
8. Some of the teachers are **untrained whereas** the school is required to appoint all the teachers who are trained and qualified as per provisions of Affiliation Bye-Laws of the Board. The school is required to maintain section teacher ratio i.e. 1.5 teachers per section at each level. Hence, a copy of revised staff statement is required to be submitted showing Name, Qualification, Designation, Date of Appointment, Date of Confirmation etc.

9. The school is required to appoint Special Educator as per rule 13(11) of Affiliation Byelaws of the Board and as mentioned in Board's circular dated 25.06.2015.
10. The school is required to appoint a wellness teacher qualified as per norms and submit the details to Board.
11. The school is required to set up maths lab and submit the evidence to Board and also intimate the size lab (l x b)
12. The school is required to pay salary Basic pay, DA and other admissible allowances either at par with the State Govt. norms or as per provisions of Vth pay commission. An evidence to this effect, a copy of acquaintance roll for the last 03 months along-with Banker Certificate are required to be submitted in support of it.
13. The school is required to submit a certificate from the concerned DEO/BEO, that the school is paying salary to its employees as per State Govt. norms.

Keeping in view, the academic interest of the students, I am directed to convey approval of the competent authority for provisional extension of affiliation upto 31.03.2020 alongwith permission for registration of bonafide candidates of class IX/XI and submission of list of existing candidates of the School for class X/XII for current session.

However regularization of affiliation from 01.04.2018 for a period of 05 years will be subject to the specific compliance of the discrepancies communicated by the School within 30 days failing which a penalty of Rs.20,000/- per month will be levied on the school and the process of withdrawal of affiliation of the School may also be initiated.
